**Sub: Fixation and Regulation of fee of Iqra Educational Institute Haji  
Abad Bemina, Srinagar.**

**Iqra Educational Institute Haji Abad Bemina, Srinagar** submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Sgr/504**.

The tuition fee of the school has been regulated by the Committee vide order No. 265 FFC of 2018 dt. 21.02.2018 for academic session 2017-18.

The annual fee of the school is being regulated by the Committee for the first time by this order.

Record shows that school management has violated order No. 265 FFC of 2018 dt. 21.02.2018 in as much as the fee fixed and regulated for academic session 2017-18 by FFC has not been fully complied with and school management has fixed higher fee for classes Pre-Nursery to 1<sup>st</sup> than what was fixed by Committee. The Chairperson and Principal to show cause within one month why action in accordance with law is not taken against them.

Record also shows that huge amount is being spent on "**Advertisement**" by school management.

It is being again re-stated that schools are learning institutions and not commercial establishments. Huge amounts cannot be permitted to be spent on such activities. Such hike activities of school management on the one hand further financially strain parents and on the other hand school managements lead institution to deficits.

In the overall circumstances and facts, and that charging of admission fee is barred by statute and court, the students who are admitted in the school for the first time (Fresh-Admission) be charged Rs.4000/- as annual fee.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, material produced by the

School management, income-expenses, income and expenditure, of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.**

The school management shall maintain an account of school funds (fee etc) in a Schedule Bank, which shall be operated by a person(s) authorized by

school management. Record about all the expenses/expenditures shall be maintained with receipts.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
