**Sub: Fixation and Regulation of fee of Noor-E-Illahi Model Secondary School Asham Sonawari, Bandipora.**

**Noor-E-Illahi Model Secondary School Asham Sonawari, Bandipora** submitted file for fixation and regulation of fee structure of the school, which has been registered in FFRC office under No. **FFRC/FF/2021/Bpr/478.**

The fee structure of the school is being regulated by the Committee for the first time by this order.

The Administrative Officer (FFRC) on perusal of school record observed that either the school record about fee structure is manipulated or facts have been suppressed.

In view of observations of Administrative Officer (FFRC), the school management/Principal was asked to submit its explanation.

In his explanation dt. 06.09.2021 mailed by Principal, it is stated that variation in income and expenditure statement 2019 is due to clerical mistake and mis-understanding about the fees.

What prima facia appears is that school management/Principal has deliberately tried to hood-wink and mislead the FFRC for seeking illegal monetary benefits, as the fresh fee structure mailed with aforesaid communication shows that tuition fee submitted earlier was exaggerated and falsely shown on higher side.

The school management/Principal to show cause as to why action according to law is not initiated against them. Reply within two months.



The new document submitted by Principal shows tuition fee is in almost all the classes less by Rs.100/- that was shown in earlier documents.

In the facts and circumstance of this case the school management shall maintain same fee structure for academic session 2020-21, 2021-22 and 2022-23. The fee structure is taken note of:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.**

The school management shall maintain an account of school funds (fee etc) in a Schedule Bank, which shall be operated by a person(s) authorized by school management. Record about all the expenses/expenditures shall be maintained with receipts.

The school management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The school management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.



**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
