Al-Maarif Higher Secondary School, Bathindi, Jammu submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Jmu/158.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

Record shows that School Management has earlier submitted one fee structure and subsequently another fee structure. Earlier fee structure is considered for regulating the fee of the School.

Printing Charge is included in Annual Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
