Ajanta Higher Secondary School, Gho Brahmana, Ramgarh, Samba submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Samba/124.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

School record shows that School Management has maintained same fee structure for academic session 2019-20 and 2020-21. In terms of Order No.45-FFRC of 2021 dated 18.02.2021, the School Management has to maintain same fee structure for academic session 2021-22.

School Management has not charged and collected Annual Fee from students for academic session 2020-21.

On 9th of August' 2021, following order was passed on School file:

"School record shows that in Annual Fee, besides other components, one of the component is shown as 'Annual Fee'. School Management/ Principal to explain and clarify same within week's time, failing which the said component will be deleted from Annual Fee."

Kindly refer your e-mail on the subject cited above, in this regards it is submitted that we have annual charges which includes 15 components with one of the component as annual charges. Which we have changed as provisional academic charges. It is stated that the fee payments are deteriorating very rapidly especially in rural areas for a variety of reasons. Our breadth of experience informs this provisional academic charges assist to minimize the loss of an unaided Pvt. School.

We have developed a streamlined debt recovery through a menial provisional academic charges per class per student by way of which we meet budgetary deficit and concessions provided to meritorious students 50% BPL students 50% and free education to Orphan students.

More over Govt. of J&K UT Deptt. Of education has ordered not to claim annual charges w.e.f 01.04.2020 to onwards. Copy of latest fee structure with change is enclosed for reference.

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
