Sub: Fixation and Regulation of fee of Himalayan Education Mission HSS Rajouri.

Himalayan Education Mission HSS Rajouri submitted file for fixation and regulation of fee structure of the School, which was received on 20th July 2021 in FFRC and has been registered under No. FFRC/FF/2021/Raj/306.

School record shows that this private school has been established on 2nd of September 1981. The School is imparting Education from Nursery to 12th standard. At 11th, 12th both Science and Arts subjects are being taught.

Perusal of the audited reports ending 31st March 2018, 31st March 2019 and 31st March 2020 make a surprising revelation, which is summarized as under;

- a) In the audited report ending 31th March 2018 from out of school funds an amount of Rs.6686620/- has been transferred to "Head Office" under the guise of loan
- b) The audited report ending 31st March 2019 shows that an amount of Rs.8612620/-has been provided as loan to "Head Office".
- c) Similarly the audited report ending 31st March 2020 show that an amount of Rs.11832620/- has been provided as loan to "Head Office".

Record also shows that in the year ending 31st arch 2018 the school has had a surplus of Rs.6423545 and in the year ending 31st March 2019 the school had surplus of Rs.10719592/- . Similarly in the year ending 31st March 2020 the records show that school had surplus of Rs.10807978/-

At this stage without going into other aspects, which would be looked into after explanation is received from school, it would be seen as to how and in which manner the surplus amount is being dealt by the school management.

The expression "Head Office" appearing in the audited report lacks description, and has no presence anywhere in the school record. Huge amounts have been transferred to the "Head Office".



The School management to explain what "Head Office" means and who is heading /managing this head office. The School Principal/ Chairperson to provide bank details of head office and person who is maintaining and operating its banks account. The Principal/Chairperson shall also provide detailed information about the utilization of the amount which has been shown to have been loaned to "Head Office."

Primafacia it appears that the school management has already commercialized the education.

The response in respect of the issues raised in this order shall be filed within week's time.

Till further orders the school management shall not make any hike in any type of fee and shall not charge and collect annual fee from the students.
