Order No: 7 -FFRC of 2021 Dated: 06 -12-2021

While scrutinizing the files submitted by School Managements for regulating the fee structure of the schools, in most of school records it is found that some important documents have not been submitted by the School Managements.

In order to enable the FFRC to regulate the fee structure of the schools, the documents which are to be submitted in the FFRC office in accordance with FFRC Proforma uploaded on its web site, to enable it to properly regulate the fee structure of the schools, the School Managements are duty bound to make good the deficiencies in their record as is highlighted by the office in respect of the schools. Some schools stand already notified about the deficiencies.

However, most of the schools till date have not made good the deficiencies in their respective records.

In the interest of justice, 10 day time is granted to all the schools for making good the deficiencies in the records, failing which appropriate order will be passed.

Till further orders, the school Managements, particulars whereof are given in Annexure-A of this order along with the deficiencies found in their records, shall not make any hike in any type of fee. These schools shall not also charge and collect Annual Fee from the Students/ Parents till further order from FFRC.

The schools which have already been reminded for the making the good deficiencies, are not included in Annexure- A. They are also directed to submit the deficiencies as per the reminder send to them within week's time.
