**Corrigendum to Order No: 805 – FFRC (FF) of 2021
Dated: 02 / 02/2022**

Sub: Fixation and Regulation of fee of Kamal Academy Higher Secondary School, Nandpur, Ramgarh, Samba.

Vide Order No. 805 – FFRC (FF) of 2021 dated 07.12.2021, Tuition Fee of Kamal Academy Higher Secondary School, Nandpur, Ramgarh, Samba, stands regulated.

On 31st of December' 2021, the Principal of the School submitted application addressed to Chairman, FFRC, in which it is stated that the Principal had alongwith record submitted details of the Annual Fee, but the School in terms of aforesaid order has been asked not to charge the Annual Fee.

In view of the aforesaid application of the Principal, the School file was again examined and it was found that alongwith record submitted by the School to FFRC on 30th September' 2021 and received in FFRC vide Receipt No.2323 on even date and registered vide No. **FFRC/FF/2021/Samba/381**, the Principal had submitted Proforma "B" for fixation and regulation of Annual Charges.

Now, it appears that while considering the record of the School for fixation and regulation of its fee structure, due to over-sight, the Proforma "B" and another document giving details of the Annual Fee has not been considered.

It becomes duty of the Committee to rectify the inadvertent mistake.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and prescribed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the



School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The Annual Fee regulated by this order will be operative after the School reopen and start offline/regular classes. The Annual Fee at that stage will be charged on pro-rata basis in terms of Government Circular No.01 – Edu of 2020 dated 14.05.2020, endorsed by FFRC in its meeting held on 18.03.2021.



The Annual Fee of the School is accordingly fixed and regulated by issuance of corrigendum to Order No. 805 – FFRC (FF) of 2021 dated 07.12.2021.

This corrigendum shall be deemed to be part of the Order No. 805 – FFRC (FF) of 2021 dated 07.12.2021, and be placed on record of the main file.




