**Sub: Fixation and Regulation of Fee of Little Angel Academy High School Kishtwar.**

Little Angel Academy High School Kishtwar submitted file for Fixation and Regulation of Fee Structure of the school registered in FFRC office under file No. FFRC/FF/2021/Kisht/216.

The Committee vide order No. 487 FFRC (FF) of 2021 dated 26-08-2021 fixed and regulated the fee of the school with the observation that "*the school has not provided the details about charging of annual fee. If the school management has any claim about annual fee, then same may be projected with detailed breakup. Until such time annual fee shall not be charged and collected from students.*"

In response to the said order the school management submitted detailed breakup of of annual fee 2019-20 and onwards with the request to approve the annual fee detailed as Annexure -I and Annexure-II.

The record was re-examined and it was found that the school had provided details of annual fee as it stood in August 2018 along with original file but due to inadvertent oversight the same was not considered in earlier order.

on due consideration of the additional information provided by the School management and after considering the record already submitted , all relevant factors which govern the subject, , the Committee finds it just and proper to fix and regulate the Annual fee of school as under;
