Subject:- Fixation, Determination and Regulation of Fee of Private Schools in UT of J&K.

Order No: 6 FFRC of 2022 Dated: 09 .03.2022

Whereas ,pursuant to Government order No.15-JK (DMRRR) of 2022,dated 13-02-2022 issued by Department of Disaster Management and RRR, Schools have been re-opened in UT of Jammu and Kashmir vide Government order No.72-JK (Edu) of 2022, dated 16-02-2022 for physical classes.

Whereas, with the re-opening of schools various complaints were received and are being received by the Committee alleging that the Private schools have made huge increase in Transport fee.

Whereas, it is also alleged that the Private school managements are demanding payment of advance transport fee either for full session or 50% of total fee. The Schools also seek an undertaking from the parents regarding advance payment of fee.

Whereas, the matter was placed before the Committee in its meeting dated 09-03-2022 and the committee resolved as under;

"that as a temporary measure and till such time final decision is taken and Final orders issued, the school managements shall make 12% hike on transport fee which was being paid by the students availing transport facility, in Oct -2019 in winter zone and Feb- 2020 in summer zone. It was also resolved that no private school shall seek any undertaking from parents/students for advance Tuition fee and Transport fee, the practice being illegal and shall not be allowed."

## The Committee accordingly directs as under;

1. The Private school managements shall make an increase of 12% in transport fee which was being paid by the students availing transport facility, in Oct-2019 in winter zone and Feb-2020 in summer Zone. This hike will be operative from the date of re-opening of schools vide orders supra.



- 2. No school shall seek any type of undertaking from the parents/students for advance payment of Tuition fee, transport fee or any other fee. However the parents are at liberty to pay the fee monthly or quarterly.
- 3. The charging of transport fee during covid-19 shall be governed by the Circular No.01-Edu of 2020, dated 14-05-2020 read with Circular No.05-JK (Edu) of 2022 dated 08-03-2022 and order No. 28 FFRC of 2020 dated 07-12-2020.
