Delhi Public School, Rajbagh Krandi, Marheen, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Kat/126.

The fee structure of the School is being regulated by the Committee for the first time by this order.

At Para – 22 of the Proforma, the School Management has mentioned that there is no proposal to enhance tuition fee, annual charges or any other charge.

Record shows that School Management is charging and collecting Rs.7,000/- to Rs.9,000/- on account of Registration Fee, Rs.7,000/- to Rs.9,000/- as Admission Fee and Rs.2,000/- as Security Fund (Refundable).

Charging and collecting of above amounts is illegal and cannot be part of either Annual Fee or Tuition Fee, in view of mandate contained in Section – 20 E (1) of Jammu and Kashmir School Education Act' 2002. Registration Fee is in essence a substitute for Admission Fee, which is barred by Statute.

Record also shows that besides charging Annual Fee, the School Management has been charging 'Annual Digital Fee' and charges 'Miscellaneous Expenditure' separately.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.
