Order No: 388 -FFRC (FF) of 2022
Dated: 25/06/2022

Sub: Fixation and Regulation of fee of Green Light (MGL) Higher Secondary School, Ishber, Nishat, Srinagar.

Green Light (MGL) Higher Secondary School, Ishber, Nishat, Srinagar submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Sgr/753**.

The fee structure of the School is being regulated by the Committee for the first time by this order.

Perusal of school record shows that the School had not submitted audited financial statements with the file and the same was sought from the school authorities vide order dated 25.10.2021, which is taken note of:

“Principal/ School Management to provide audited financial statements of last three years within weeks time. Till further orders school management shall not make hike in any type of fee.”

On failure to comply with the above-said order, another e-mail on 03.01.2021 was sent to the Principal of the School, in which he was directed to comply with the order dated 25.10.2021 and to submit the deficiencies in accordance with the mandate of the Order No.72-FFRC of 2021 dated 06.12.2021.

However, the Principal/School Management again failed to comply with these orders and on 25.02.2022, another order was passed, which is taken note of:

“Principal/ School Management has failed to comply with order dated 25.10.2021 and January’ 3 – 2022. The Principal/ School Management is directed not to make hike in any type of fee till further orders. They are also directed not to collect Annual Fee from the students. The fee structure of the school could not be regulated till date as the



Principal has failed to make good the deficiencies notified to him earlier.

Chief Education Officer shall get this order implemented through concerned ZEO and report compliance.”

In the meanwhile, complaint was lodged on 03.03.2022 by a group of parents of the School, alleging therein that the school authorities are hiking fee on their own choice. Copy of the complaint form part of the record.

On 28.04.2022, Er. Khurshid Ahmad Mahajan, the Chairman of the School, submitted audited financial statements of the School alongwith a representation, in which while feeling sorry for delay in submission of the same, also mentioned various reasons for such delay. The said representation and audited financial statements also form part of the record.

On 07.05.2022, with the orders of the Chairperson, FFRC dated 06.05.2022, an inspection of the School was conducted, report of which is placed on record of the file.

During inspection, besides other issues, some important issues regarding Tuition Fee and Annual Fee of the School were discussed by inspection team with the Chairman of the School. In response to that discussion, Er. Khurshid Ahmad Mahajan, the Chairman of the School, submitted a separate representation/undertaking in FFRC on 09.05.2022, which has been placed on record. The representation/undertaking is taken note of:

Subject:- Clarification regarding charging Rs.2000 /year extra from students having 5th subject Additional other than Physical Education, Functional English, Islamic Studies.

Respected Sir,

This is with reference to our Fee Fixation file submitted to your office vide reference No.FFRC/FF/2021/Sgr/753. This is to bring into your kind consideration that the students of Classes 11th & 12th who opt for 5th subject other than Physical Education, Functional English, Islamic Studies will have to pay an additional amount in between Rs.2000/Year to 5000/Year extra other



than normal fees depending upon the number of students in that particular subject like (Information Practice, Economics, Mathematics, Business Mathematics, Computer Science or Environmental Science etc.). For 2 students Rs.5000/- per year extra, for 3 students Rs.4000/- per year extra, for 4 students Rs.3000/- per year extra and for 5 students only Rs.2000/- per year extra.

It is also pertinent to mention that the ANNUAL CHARGES includes following funds:

1.Games Fund 2.Red Cross & First Aid Fund 3.Printing & Stationery Fund 4.NEET/IIT-JEE Study Material for class 11th & 12th 5.School Software Maintenance Fund 6.Computer & Internet Fund 7.Laboratory & Library Fund etc.

We also undertake that the hike of Rs.100/month from Class Pre-Nursery to Class 10th & Rs.250/month for Class 11th & 12th from current academic session shall be confirmed after due approval of FFRC and shall be adjusted with tuition fee for next month.

Finally your good self is requested to take final decision regarding the Fixation of FEES for current academic session and we assure your good self that your decision shall be implemented in letter and spirit.

Looking forward for favourable & sympathetic action at your end.

The school representation shows that the School Management has hiked the tuition fee for current session viz; 2021-22 by Rs.100/- per month for classes from Pre-Nursery to 10th and by Rs.250/- per month for classes from 11th & 12th. It has been undertaken by School Management/ Chairman of the School that in case this hike is not approved by FFRC, then they will adjust the excess fee in the future tuition fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and prescribed by



Statute and Statutory Rules notified vide S.O. 233 dated 10.05.2022. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income-expenses, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

An educational institution is being set-up primarily to impart quality education to the students. The School Management shall advert its attention and give priority for imparting quality education to the students.

The School Management shall publish only FFRC orders about fee structure and Government Education Department's notices in newspapers. No publicity through advertisement shall be made about School, same being not a business unit.



Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

School Management shall not sell uniforms and books in the school premises. The students will be at liberty to purchase books and uniforms at the place of their choice.

Any land/building/vehicle purchased, or building constructed from out of School Funds, in law will be property of School and shall vest in School.

School Funds have to remain in School Corpus and have not to be transferred to any other account excepting the school account.

The School Management shall maintain an account of School Funds (Fee etc.) in a Schedule Bank, which shall be operated by a person(s) authorized by School Management. Record about all the expenses/expenditures shall be maintained with receipts.

All types of fees shall remain in School account and no amount shall be paid or transferred to Trust/ Association of Persons (AoP)/ Body of Individuals (BoI).

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School Management shall also make reasonable annual hike in salary of its employees viz; teaching and non-teaching staff.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.


