Subject: - Fixation, Determination and Regulation of Fee of Private Schools in UT of J&K.

Order No: 13 FFRC of 2022 Dated: 31 .10.2022

Whereas, the Committee for Fixation and Regulation of Fee of private Schools vide Order No.35 FFRC of 2021 dated 19-01-2021 directed all Private Schools of UT of J&K to Submit information as per the proforma available on Committees website www.jkffc.in for approval of fee structure, within 30 days.

Whereas, the On the request of Private school Associations and individual schools the time period for submission of files was extended from time to time and a final opportunity was given to Private schools of UT of J&K to submit files by or before 30th September 2021.

Whereas, the Committee considered the request, and vide order No. 02 FFRC of 2022 dated 20-04-2022 extended the date up to 25-05-2022.

Whereas, the Government of Jammu & Kashmir notified the Jammu and Kashmir Private Schools (Fixation. Determination and Regulation of Fee) Rules. 2022 on 10th May 2022 vide S.O No 233.

Whereas, the rule 8 a of the Jammu and Kashmir Private Schools (Fixation, Determination and Regulation of Fee) Rules 2022, provides that "the private School shall submit a proposal to the Committee on the proforma as may be prescribed by the Committee. The proposal for fixation, determination and regulation of fee for next year shall be submitted three months before the next academic year starts".



Whereas, the Academic session in winter zone commences in November and in Summer Zone it commences in April.

Accordingly, in terms of Rule supra, vide order No.03 FFRC of 2022 dated 10-06-2022. Private Schools of summer zone were asked to submit files for fixation and regulation of fee by or Before December 31st (before 03 months of commencement of Academic Session). Similarly Private schools of winter Zone were asked to submit files by or before 31st July (Before 03 months of commencement of Academic Session).

Whereas, during this period the committee regulated fee structure of more than 1200 schools of UT of J&K for three sessions in each case.

Whereas. In winter zone the fee was regulated for the session (s), 2021-22, 2022-23 and 2023-24, in other cases 2022-23, 2023-24 and 2024-25.

Whereas. In summer zone the fee was regulated for session (s) 2021-22, 2022-23 and 2023-24. In other cases 2023-24, 2024-25 and 2025-26.

Meanwhile Government of UT of J&K vide Order No. 2074-JK (Edu) of 2022 dated 31-08-2022 read with order No.2085-Jk (Edu) of 2022 dated 07-10-2022, has made uniform academic calendar (March-April Session) operational in whole UT of Jammu and Kashmir.

Whereas, The new academic session in winter zone like in Summer Zone will now commence in April 2023 instead of Nov-2022 in line with uniform Calendar.

Now, therefore in line with uniform academic calendar and to bring clarity, it is ordered that:

1. In winter zone the fee structure regulated by the Committee for Session 2022-23 will be applicable from April 2023 to March 2024 (2023-24). instead of



Nov-2022 to Oct-2023 (2022-23). The fee structure for 2023-24 will be applicable for 2024-25 and 2024-25 for session 2025-26 respectively.

- 2. In Summer Zone the session begins in March-April and fee has been regulated accordingly as such there will be no change. The Schools shall collect fee as regulated by the Committee.
- 3. In case any private school in winter zone has received advance fee in Nov-2022 from parents for coming session (2022-23), the same will be applicable from April-2023
- 4. Violation, if any, shall warrant action in accordance with Law.
