- 4. $10^{th} = 880$

The school in violation of order supra was charging fee during 2018-19 as under;

- 1. 1^{st} to $6^{th} = 760$
- $2. 7^{th} = 840$
- $3.8^{th} = 890$
- 4. $9^{th} = 970$
- 5. $10^{th} = 990$

The school has made enhancement on the above fee for the year 2019-20. No hike has been made during 2020-21 and 2021-22.

Annual Fee; the school was charging annual fee in 2019-20 as under;

- 1. 1^{st} to 4^{th} = 3000
- 2. 5th = 3300
- 3. $6^{th} = 3800$
- 4. 7^{th} to 10^{th} = 4500

On examination of annual fee statement submitted by the school, it was observed that few heads under which such fee is being charged are either a one-time investment, voluntary in nature or with no proper justification, hence not considered while fixing annual fee.

On due consideration of the material produced by the School management, the financial aspects, observations reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and regulate the fee structure of the school as under;
