Evergreen Model academy Kun Katra Zone Reasi Submitted its file registered under No. FFRC/FF/2022/Reasi/19 in this office for fixation and regulation of fee structure of the School. The fee of the school is being regulated for the first time by the Committee.

The record submitted by the school was examined and following observations were made;

- The average tuition fee charged by the school as per fee statement in 2019-20 is 644 per student.
- Average tuition fee as per audit report per student is 590/-
- Average expenditure per student against tuition fee per student is 538/-
- Average annual fee as per audit report is 2185/-
- Average expenditure against annual fee is 2617.

Financial statement 2018-19

- Average Tuition fee as per audit report is 492/-
- Average Expenditure against tuition fee is 463/-
- Average annual fee as per audit report is 1381/-
- Average expenditure against annual fee is 1603/student.
- Average Annual fee as per the fee statement Aug-2018 is 4500.

There is a huge discrepancy between the average amount of annual fee charged in Aug-2018 shown by school which in average is 4500 and amount worked out as per audit report, it is 1381. Similarly in 2019-20, the annual fee as per income & expenditure statement is 2185.

The school as per the fee statement is continuing with the same fee structure from 2014-15 to 2021-22 which shows the school is running smoothly with the tuition fee being charged presently. In case of annual charges the report shows Average expenditure (Rs. 2617) as per 2019-20 financial statement overweighs Average income (Rs.2185) by average Rs 432, which is considered. The analysis prima facie shows the annual fee is manipulated on higher side evident from audit report of 2018-19 with average income of Rs.1381 and Rs.2185 in 2019-20 which is far from the average amount of 4500 as per fee statement submitted by the school.

in case of annual charges the report shows Average expenditure overweighs Average income which is considered and a reasonable amount is fixed with a reasonable hike subsequently.



On due consideration of the material produced by the School management, the financial aspects reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and and regulate the fee structure of the school as under;
