**Sub: Fixation and Regulation of fee of Global Mission School Thannamandi,
Zone Thannamandi,Rajouri.**

Global Mission School Thannamandi, Zone Thannamandi, Rajouri Submitted its file registered under No. FFRC/FF/2022/Raj/92 in this office for fixation and regulation of fee structure of the School. The fee of the school is being regulated for the first time by the Committee.

The record submitted by the school was examined and following observations were made;

- The school in 2019-20 was charging Tuition fee ranging between Rs.500/- to Rs.750. Annual Fee was being charged in the range of 1025 to Rs.1840/-
- The school is charging annual fee under Library Security fund @ 200 in all classes with no justification for creating such head.
- Electricity charges are also included in annual fee which otherwise is a component of tuition fee. News fund is charged in all classes @ 75/- to 100 with meagre expenditure of Rs.2100 in 2019-20 and Rs.950/- in 2021-22.

Financial position of the School.

- In 2019-20, 2020-21 and 2021-22, the school has generated surplus of 10%, 11.6% and 21% respectively.
- The recurring expenses in 2019-20, 2020-21 and 2021-22 are Rs.215, 212 and 225 per student per month respectively against average T.F of Rs.625 calculated as per fee structure.
- The average expenses in 2019-20 against annual fee are 924 per student per annum against average annual fee of Rs.1223 per student per annum.
- Library Security fund @ 200 charged by the school prima facie has no justification hence is not considered. Electricity charges are a component of tuition fee thus removed from annual fee.
- News fund is charged in all classes @ 75/- to 100 with meagre expenditure of Rs.2100 in 2019-20 and Rs.950/- in 2021-22.

The financial analysis shows that the school management is spending a meagre amount for growth and development of education evident from the details of expenditure. Income is more but expenditure is far less which may result in commercialization on one hand and low quality of education in future.



On due consideration of the material produced by the School management, the financial aspects, observations reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and regulate the fee structure of the school as under; which shall be subject to review in case school management fails to take steps for improvement in quality of education.


