- The analysis of income and expenditure statement shows that the school is in surplus of 33% to 47% during last three years.
- Very low amount is paid as salary to staff ranging from 2000 to 4000.
- Meagre amount is spent on improvement of educational infrastructure and facilities evident from the surplus school is generating for last three years.
- Such a surplus amounts to commercialization/Profiteering.

On due consideration of the material produced by the School management, the financial aspects, observations reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and and regulate the fee structure of the school as under;
