New Model High School Korotana R.S Pura Jammu.Submitted its file registered under No. FFRC/FF/2022/Jmu/38 in this office for fixation and regulation of fee structure of the School. The fee of the school is being regulated for the first time by the Committee.

The record submitted by the school was examined and following observations were made;

- The School is showing deficit as per the income and expenditure statement, which prima facie appears manipulated.
- In 2019-20,the income through tuition fee shown in financial statement is Rs.508320/-. The same when calculate manually on the basis of class wise enrolment and actual tuition fee charged by the school, the amount turns out Rs. 1057800, thus showing a huge disparity.
- The average tuition fee in 2019-20 in terms of income shown in financial statement is Rs.242 while as it is around 500/- when taking actual fee structure of the school as basis. This again shows the fee either fee structure or audit report is manipulated.
- The school has submitted details of annual being charged by the school but nowhere in the financial is the income received through annual fee reflected. This too is manipulated.

On due consideration of the material produced by the School management, the financial aspects, observations reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and and regulate the fee structure of the school as under;
