## Office of the Chairperson Committee for Fixation & Regulation of Fee of Private Schools, J&K (FFRC)

Sub: Fixation and Regulation of fee of Montessori Nirmal Public High School Basti Rangpur Sadhray,R.S Pura.

Montessori Nirmal Public High School Basti Rangpur Sadhray,R.S Pura.Submitted its file registered under No. FFRC/FF/2022/Jmu/95 in this office for fixation and regulation of fee structure of the School. The fee of the school is being regulated for the first time by the Committee.

The record submitted by the school was examined and following observations were made;

- The School has made enhancement in its Tuition fee during 2021-22 in the range of Rs.60 to Rs.80. The school is presently charging tuition fee in the range of 620 to 920 including student welfare fund in the range of 160 to 240 which otherwise is component of annual fee.
- Annual Fee; the school is charging annual fee in the range of 3900 to 5500 under various heads as per the fee statement submitted by the school. But the financial statement of 2019-20 shows income under few heads (School welfare fund, Examination Fee, Computer Fee, Lab. Fee, Registration fee) averaging 2030 per student revealing that the school shall actually be charging 2030 as annual fee.
- For instance school is charging Rs. 300 from each student under the head news and Magazine but the expenditure related to this head during previous years is around 10000/yr. similarly under head teaching Aids, the school is charging Rs. 800/- to 1200 but the related expenditure is around 30000/-
- Under head computer fee the school is charging Rs. 1000 from 1<sup>st</sup> to 10<sup>th</sup> but the income through this head is shown far less as reflected in financial statements.
- The student welfare fund is remove from the tuition fee and is added to annual fee.

On due consideration of the material produced by the School management, the financial aspects, observations reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and and regulate the fee structure of the school as under;

Non- compliance will attract penal action under Law.

The school management is at liberty to seek redressal of grievance if any regarding approved fee structure by making a proper representation before the Committee.

(The school management shall display this approved fee structure on the school notice Board and upload the same on school website. The management shall also publish the approved fee structure in a leading daily news paper.)
