The record submitted by the school was examined and following observations were made:

- The school is charging Tuition fee at uniform rate of Rs.1000 per month in all classes.
- In 2019-20 the school was charging annual fee @ 4000 per student
- In 2022-23 the school has hiked the annual fee by exorbitant ant amount of Rs.2000/ and was charging 6000 annual fee.
- The details of annual fee shows the school is charging Registration fee not permissible under statute. Similarly School improvement fund is charged on exorbitant rate of Rs.3000/

In 2019-20The school has suffered a loss of Rs.145637 and in 2020-21 has generated a little surplus.

Keeping in view the developing stage of the school and on due consideration of the material produced by the School management, the financial aspects reflected supra and after considering all relevant factors which govern the subject, the Committee finds it just and proper fix and and regulate the fee structure of the school as under;
