Kite Highlands School Gogo Rawalpura Srinagar submitted file for fixation and regulation of fee structure of the school which has been registered in FFRC office under No. FFRC/FF/2022/ Sgr/1100.


The Fee Structure of the school is being regulated by the committee for the first time by this order.

School Record shows that the school is run as a proprietorship concern. Education is not commerce but charity. When an institution, more particularly, an educational institution is set up, it effects a large section of society and assumes the character of public trust.

The school management to take immediate steps for putting the school on legal track and submit compliance report within two (02) months.

Excursion/Stationary LPD are voluntary in nature and are excluded from the Annual Fee.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by Statute and Statutory Rules notified vide S.O. 233 dated 10.05.2022. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, receipts-payments, income and expenditure of the School and after considering all other relevant factors which govern the subject, including infrastructural facilities and quality of education provided by the school, the Committee finds it just and proper to regulate the fee structure of the School as under:
