
**Sub: Fixation and Regulation of fee of Khalisa Higher Secondary School

**The fee structure of the school has been regulated by this committee vide
order No : 88 FFC of 2016 dated: 20-09-2016 for the session 2015-16.**

**Record also shows that School Management has maintained same Tuition Fee
from the academic session 2015-16 to 2021-22**

The record produced and the justification given by the School Management for
fixation and regulation of fee structure of the School was examined. The same was
considered in accordance with norms set out in various judgments and prescribed by Statute
and Statutory Rules notified vide S.O. 233 dated 10.05.2022. On due consideration
of the entire conspectus of the school record and acknowledged parameters and settled
norms for regulating the fee structure of the School, material produced by the School
Management, receipts-payments, income and expenditure of the School and after
considering all other relevant factors which govern the subject, including infrastructural
facilities and quality of education provided by the school, the Committee finds it just and
