

**New Model Institute of Education Waghama Bijbehara Anantnag** submitted file for fixation and regulation of fee structure of the School which has been registered in FFRC office under No. **FFRC/FF/2022/Ang/1112**.

The fee structure of the school is regulated by this committee for the first time by this order.

**The fee structure of the school is being regulated by this committee for the first time by this order.**

The record submitted by the school shows that the school is charging fee on exorbitant rates. The School was asked to produce record viz Fee Receipts and Fee register to clarify its position. During examination of records it was observed that the school management was actually charging fee less than as was submitted in the FFRC application for regulation of its fee structure. The School Management accepted the fault as error after which the fee was fixed in light of the explanation submitted by the school management.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgments and prescribed by Statute and Statutory Rules notified vide **S.O. 233 dated 10.05.2022**. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, receipts-payments, income and expenditure of the School and after considering all other relevant factors which govern the subject, including infrastructural facilities and quality of education provided by the school, the Committee finds it just and proper to regulate the fee structure of the School as under:
