Subject: - Charging of Processing Fee alongwith Proposal of Fee Fixation and Regulation.

Order No: <u>O</u> 4 FFRC of 2023 Dated: <u>A</u> 6 .12.2023

Whereas, the Committee For fixation and regulation of Fee of Private Schools is a statutory body constituted under Section 20A of Jammu and Kashmir School Education Act 2002 amended from time to time.

Whereas, Rule 8(a) of Jammu and Kashmir Private Schools (Fixation, Determination and Regulation of Fee) Rules, 2022 provides that "The Private school shall submit a proposal to the Committee on proforma as may be prescribed by the Committee. The Proposal for fixation, Determination and Regulation of fee for next year shall be submitted three months before the next academic session."

Whereas, Rule 8(b) of Jammu and Kashmir Private Schools (Fixation, Determination and Regulation of Fee) Rules, 2022 provides that "the Private School shall pay such amount towards the processing fee, as may be prescribed by the Committee alongwith the Proposal".

Whereas, In exercise off powers conferred under rule 8(b) of Jammu and Kashmir Private Schools (Fixation, Determination and Regulation of Fee) Rules, 2022, the Committee in its meeting dated 30-09-2023 decided to fix the processing fee to be charged alongwith the proposal for fixation and Regulation of Fee from Private Schools of UT of J&K as under;

S.No	Private Schools with Annual income upto Rs. 50.00 Lac.	Rs. 3000
01	Private Schools with Annual income Rs. 51.00 Lac to 2 Crores	Rs.6000
02	Private Schools with Annual income above Rs. 2 Crores	Rs. 10000

Now therefore, it is ordered that;

- 1. Each private school shall pay requisite processing fee alongwith the proposal for Fixation and Regulation of Fee.
- 2. The procedure cum account details for payment of such processing fee will be notified separately.
- 3. This order will have effect from 30-09-2023.
