Further the record produced by the school management reveals that the school is not collecting/charging any type of fee viz Tuition Fee or Annual Fee. However, the school management is paying salary to the staff and other expenses for smooth functioning of the school from the donations received by the trust.

The Committee directs the school management to run the school from the donation received and if in future the school management decides to collect the tuition fee from the students, the school management will have to get the approval from the FFRC.


