Subject: Approval for REVIEW/MODIFICATION FOR DETERMINATION, FIXATION & REGULATION OF FEE STRUCTURE OF "GREEN VALLEY EDUCATIONAL INSTITUTE ELLAHI BAGH SRINAGAR".

The School Management of Green Valley Educational Institute Ellahi-Bagh, Srinagar has filed a review application informing that those students who are studying in class 1st and 2nd are as per the fee structure 2024-25 fixed by the Committee paying Rs. 3425/-. The same students when they are promoted to Class 3rd have to pay a fee structure Rs. 2740/- similarly, the Annual Fee of Class 1st was being charged by the School @ Rs 15000/- per annum which was reduced by this Committee to Rs. 4500/-. Once the same student is promoted to Class 2nd and 3rd his annual fee also gets reduced. As such these students are already paying higher fee in their previous classes should continue to pay the same fee with whatever rise, the committee gives for the subsequent year 2025-26, 2026-27. The Committee has considered this. It is true that the fee of students studying in class 1st and 2nd are paying higher fee which gets reduced once they are promoted to class 3rd and 4th which is true about the annual fee fixed for students studying in class 1st. We find that there is justification in the request made by the School Management. These students were already paying higher fee of Rs.3425/- and Annual Fee Rs. 4500/- as per the order of the Committee the same gets reduced in higher classes. It will be appropriate if the students who were already paying higher fee are directed to continue to pay same fee paid in 1st and 2nd & to pay the same fee with whatever rise the committee order in next classes for the session 2025-26 & 2026-27. So, this review application is allowed.
