The school fee was fixed vide order No. 194 FFRC of 2024 dated: 29-11-2024. A review application was filed by the school management seeking an enhancement of the fee structure on the grounds that the total revenue of the school from tuition fees is Rs. 17.20 lakh, whereas the expenditure on salaries and rent is Rs. 21.91 lakh. It is stated that this aspect was not examined by the Committee while regulating the fees. In view of this, the review is allowed.

As per the records, the school is running at a deficit. Therefore, the order is reviewed, and there shall be an enhancement of Rs. 30/- per month in the tuition fee for all classes, over and above the fee fixed by the Committee.
