The fee of the school was fixed vide **Order No. 52-FFRC of 2025, dated 14-01-2025**. A review application has been filed by the school management seeking the grant of a one-time annual fee. It is stated that the school had requested this benefit, as most other schools have been granted the same. The Committee has considered the submission of the school and is of the view that this request was not taken into account while fixing the fee. Accordingly, a one-time annual fee of ₹5,000, ₹6,000, and ₹7,000 is granted for the sessions 2024-25, 2025-26, and 2026-27, respectively.


