Subject: Approval of Review of Fee Structure of "SIR SYED MISSION INSTITUTE NOWGAM VERINAG, ANANTNAG.

A review has been filed by the school management against Order No. 194 FFRC of 2023, dated 23-09-2023. It is stated that the Committee had fixed the fee structure for the session 2024-25 onwards, with a reduction in tuition fees averaging ₹60 per month and ₹150 annually in the Annual Fee.

• Accordingly, the submission made by the School was considered by the Committee. While regulating the School's fee structure, it appeared that the School was operating at a deficit. However, the Committee had not taken into account the expenditure incurred on maintenance and depreciation of items used within the School.

In light of the above, and in the interest of justice, it is deemed appropriate to revise the fee structure of the School for the sessions 2023-24 to 2025-26. Therefore, the review is allowed with the following revised fee structure:


