Subject: Approval for Review of fee structure of "RADIANT PUBLIC SCHOOL BATENGOO, ANANTNAG."

Order NO. 266-Sgr FFRC of 2025

Dated 06 / 10 / 2025

The Committee has regulated/approved fee structure of the School in question vide order No. 461-FFRC of 2025, Dated: 02.04.2025.

A review application was filed by the school management against Order No. 461 FFRC of 2025, dated 02.04.2025. It is stated that the school is unable to meet its financial requirements based on the fee structure fixed by the Committee as per the aforementioned order.

It is further stated that the monthly income, including both tuition and annual fees, amounts to ₹63 lakhs, while the expenditure on staff salaries alone is ₹99 lakhs. The Committee, while examining the records, did not take this aspect into consideration, despite the relevant data being available.

We have considered the school's submission and examined the records. It is evident that the school's monthly income is less than its expenditure. Based on the audit report, the school is operating at a deficit of ₹68.00 lakhs.

A direction was issued to the school to increase staff salaries by no less than 10%. As a result, the school management states that it has implemented the salary hike for the 2024-25 sessions. Consequently, the total income received from tuition fees is ₹8.21 crore, while the expenditure stands at ₹8.89 crore.

In view of this, the Committee has considered the matter and revised the fee structure which was approved by the Committee vide aforementioned order. Also the school had previously been granted a one-time annual fee by the Committee under its earlier order dated 11.01.2021. However, while regulating the fee structure, this aspect was not considered in the order dated 02.04.2025. Therefore, a one-time annual fee for new entrants in Pre-Nursery/Nursery is approved at ₹10,000 for 2024-25, ₹11,000 for 2025-26, and ₹12,000 for 2026-27.

Meanwhile, the school has been upgraded up to Class 12TH, and the fee structure submitted by the school for Classes 11th and 12th is hereby approved for the session 2024-25 and enhancement of 6% & 6% for the session 2025-26 & 2026-27 respectively. **The revised order shall be prospective in nature.**
