**Subject: Approval for Review of Fee Structure of "JK PUBLIC SCHOOL HUMHAMA BUDGAM.**

**Order No:** 345 - Sge FFRC of 2025

A review application has been filed by the school management against Order No. 96-FFRC of 2025 dated 16.01.2025. It has been stated in the review application that the Committee had earlier regulated the fee structure of the school vide its order dated 13.09.2021, as detailed below:

The school management had filed a writ petition against the order dated 13.09.2021, and the Hon'ble High Court, vide its order dated 19.09.2021, quashed the said order. The relevant portion of the judgment is reproduced below:

**"Accordingly, the impugned order dated 13.09.2021 is quashed and the matter remanded to the Fee Fixation Committee for reconsideration and refixation of fees after taking into account the factors mentioned under Rule 7 of the Rules, in accordance with law."**

The Committee, vide its order dated 16.01.2025, had regulated the fee structure of the school by taking into account the earlier order dated 13.09.2021. It is further stated that since the order dated 13.09.2021 had already been quashed by the Hon'ble High Court, the Committee, while issuing the order dated 16.01.2025, inadvertently did not consider the said judgment. As a result, the fee was fixed on the basis of the quashed order dated 13.09.2021.

The school management has submitted the following fee structure which, as per records, was being charged from the students:

The Committee has examined the submissions made by the school. It is found that, while regulating the fee vide order dated 16.01.2025, the judgment passed by the Hon'ble High Court was not taken into consideration. Since the Hon'ble High Court had already quashed the order dated 13.09.2021.

It is also pertinent to mention that the fee being charged by the school coincides with the audit report duly signed by the Chartered Accountant.

The review application filed by the school is considered, and the following revised fee structure is approved accordingly:
