The fee of the school was fixed vide the above-referred order. A review application has been filed by the school management seeking an enhancement of the fee structure as it is insufficient to make operational and academic expenditures in the school. We have considered the application. The fee is fixed on the basis of projected audit report which clearly explains the expenditure of the school. The school is running in surplus as per projected audit report. Now the school management has submitted examined/audited audit report and on the basis of it, the following fee structure is proposed for approval along-with one time annual fees. In the interest of maintaining uniformity, this prayer is allowed. Accordingly, a one-time annual fee is granted in favor of the school in question at the following rates for Nursery classes' ₹8,000 for the session 2024-25, ₹9,000 for the session 2025-26, ₹10,000 for the session 2026-27.

The revised fee structure is prospective in nature. Non-compliance will attract penal action under Law.


