Subject: Approved Review/ Modified Fee Structure of "BANGIL EDUCATIONAL INSTT. UTIKOO TANGMARG BARAMULLA."

Order NO. 794-Jmu/ FFRC of 2025

The School Management of the aforementioned institution has filed a review application against Order No. 306 FFRC of 2024, dated 06-12-2024. It has been stated that the School had sought an enhancement of 40% in respect of Tuition Fee and 25% in respect of Annual Fee. A direction was issued in the said order for enhancement of salary in favour of staff members @ 10% per annum.

Despite the fee having been enhanced @ 5% on average, the School is still running in deficit to the extent of Rs. 3.00 lakh. The Management has further stated that they are not in a position to meet the expenses.

The Committee has considered the matter and found that the School is indeed running in deficit of Rs. 3.00 lakh. As it is a low-budget School, the review filed by the Management appears genuine.

Accordingly, the review is allowed with following revised fee structure over and above the fee fixed vide Order No. 306 FFRC of 2024, dated 06-12-2024.
