Subject: Approved Review/ Modified Fee Structure of "GREEN MODEL HSS DODA."

Order NO. 797-Jmu/FFRC of 2025

The School Management of the aforementioned institution sought a review of Order No. 286 FFRC of 2024, dated 04-12-2024. The School has contended that it was running a deficit of Rs. 89 lakh at the time of submission of the file before the FFRC, and even after the revision of the fee structure, the School continues to run a deficit of Rs. 33.14 lakh.

It has further been submitted that the one-time annual fee for first-time entrants in Nursery was raised only marginally by 5 %,

Upon consideration of the review application, it is found correct that the School is presently running a deficit of **Rs. 33.14 lakh**, even after the revision ordered on 04-12-2024. It is also noted that a minimum annual salary increment of 10% has been directed to be paid to the staff.

In view of the facts and circumstances of the case, the following revised fee structure is approved:
