It has been stated that the School had not enhanced any kind of fee from 2018 to 2023 and school has submitted fee structure mentioned in Box 'A' while as Committee has fixed fee vide its order No. 11 FFRC of 2025, dated; 09-01-2025 on the basis of previous fee structure which is mentioned in Box "B", due to which school is running in deficit of Rs 21.00 lakh.

Accordingly, the review is allowed with and following revised fee structure has been approved on the basis of above mentioned fee structure reflected in Box "A" for the sessions 2024-25, 2025-26 & 2026-27 respectively and approval of One-time annual fee for nursery class @ 8000/-, 9000/-, & 10000/- for the sessions 2024-25, 2025-26 & 2026-27 respectively has been granted.
