**Subject: Approved Review/ Modified Fee Structure of "INGENIOUS SCHOOL OF EDUCATION MALLABAGH SRINAGAR."**

Order NO. 855-Jmu / FFRC of 2025

The School Management of the aforementioned institution sought a review of Order No. 555 FFRC of 2021, dated 07.10.2021. The School has contended that it was running a deficit of Rs. 42 lakhs at the time of submission of the file before the FFRC, and the Committee has approved fee structure as mentioned below in BOX "A" vide above order;

During Covid period School has not charged any kind of Annual fee, and on the basis of that Committee has fixed the fee which is reflected at Box "A" above.

The Committee has approved fee of the School on the basis of fee fixed at Box" A" for the sessions 2024-25, 2025-26 & 2026-27.

The School Management has again filed review with the request that fee may be approved on the basis of fee mentioned in Box" B" with annually increment.

It has further been submitted that the *one-time annual fee for first-time entrants* may also be approved.

Upon consideration of the review application, it is found correct that the School is presently running a deficit of **Rs. 42 lakhs**, even after the revision ordered on 11-12-2024. It is also noted that a *minimum annual salary increment of 10%* has been directed to be paid to the staff.

In view of the facts and circumstances of the case, the following revised fee structure is approved:

Enhancement in Tuition Fee for all classes approved w.ef. 2019-20 session up-to 2023-24 prospectively and further 6% enhancement approved over and above the fee fixed vide Order No. 362 FFRC of 2024, dated 11-12-2024.

Enhancement in Annual Fee for each class approved w.e.f session 2019-20 up-to session 2023-24 prospectively and 7% enhancement for 2024-25, 2025-26 & 2026-27 over and above the fee fixed vide the aforementioned order.

One-Time Annual Fee for Nursery class only (First Entrants) is approved @ Rs. 10000/- for the year 2024-25, Rs. 11,000/- for the year 2025-26, & Rs. 12,000/- for the year 2026-27.

Meanwhile, the School has been up-graded up-to the class 10<sup>th</sup> vide order No. AFFI 000603, Dated: 13-Sep-2024., so fee structure submitted by the school for the up-graded classes has been approved which is mentioned in revised fee structure below:
