Subject: Approved Review/ Modified fee structure of "ISLAMIC REVIVAL INTERNATIONAL SCHOOL KANGAN GANDERBAL."

Order NO. 766-Jmu FFRC of 2025

Dated 11/12/2025

The School Management of the aforementioned institution sought a review of Order No. 168-Sgr-FFRC of 2025 dated 25-09-2025. The management of the School has stated that the fee of the School was fixed by this Committee vide its order No. 463 FFRC of 2021, dated: 23.08.2021 and the fee fixed vide aforementioned order for the sessions 2020-21 2021-22 & 2022-23 is as under:

It has further been submitted that same Fee has been fixed for all the three years. The School had already filed a review against the order dated: 23.08.2021 which was not considered by the erstwhile Committee. The present order dated 25.09.2025 enhanced the fee structure of the School on the basis of previous order (463 FFRC of 2021, dated: 23.08.2021) without taking into consideration the review filed by the School against order dated 23.08.2021. We have considered this review application. It is apparent from the order dated: 23.08.2021 that only one fee structure was provided for all the three years, which couldn't have been done.

Therefore, we are inclined to accept the review filed against the order dated 23.08. 2021. It is also important to mention that the school is running in deficit of about Rs 42.00 lakh as per present Fee structure and 1.42 lakh as per audit report.

Upon consideration of the review application, it is found correct that the School is presently running a deficit of Rs. 42.00 lakhs, even after the revision ordered on 25.09.2025. It is also noted that a minimum annual salary increment of 10% has been directed to be paid to the staff.

In view of the facts and circumstances of the case, the Tuition Fee and Annual Fee need to be revised with effect from 2020-21. Consequently, for the subsequent years 2020-21, 2021-22, and 2022-23, annual enhancement has also been made.

The order dated 23-08-2021 has been reviewed and revised because this Committee had fixed the same fee for all three years, which was not legally permissible. In view of this, the fee structure of the school is now fixed on the revised fee structure, along with the review of the order dated 23-08-2021, as a consequence of which the fee fixed by this Committee on 25-09-2025 stands revised.

Consequently, the Annual Fee has also been revised in view of the fact that the review of the order dated 23-08-2021 has been allowed.

There shall be a One-Time Annual Fee for Nursery (First Entrants):
Rs. 8,000/- for the year 2024-25, Rs. 9,000/- for the year 2025-26, Rs. 10,000/- for the year 2026-27

Non-compliance will attract penal action under Law.


