Subject: Approved Review/ Modified Fee Structure of "SHAHEEN PUBLIC HSS FARIDABAD DODA."

The School Management of the aforementioned institution has filed a review application against Order No. 276 FFRC of 2024, dated 04-12-2024. The School Management states that despite the fee having been enhanced @ 5% on average, the School is still running in deficit to the extent of Rs. 36.89 lakh. The Management has further stated that they are not in a position to meet the expenses. School management seeks review of said order by enhancing the tuition fee @30% & Annual Fee @ Rs 3000/=.

The Committee has considered the matter and found that the School is indeed running in deficit of Rs 36.89 lakh, which factor seems to have been not considered by the Committee.

Accordingly, the review is allowed with following revised fee structure and one-time annual fee for nursery is approved @ 7000/= 8000/= & 9000/= for 2024-25, 2025-26 & 2026-27 respectively.
