Whereas, an application/request has been received from the management of "**VED MANDIR PATHSHALLA, AMBPHALLA JAMMU**" seeking fixation of fee;

whereas, the management of "**VED MANDIR PATHSHALLA, AMBPHALLA JAMMU**" submitted that the Ved Mandir Committee, Amphalla, Jammu, is a Registered Orphanage and is run by the elected Committee constituted under the Act where Orphan Children are being looked after by providing them residential accommodation & imparting education besides essential facilities without charging any kind of Fee;

whereas, it has been clearly stated and verified that **the management of VED MANDIR PATHSHALLA, AMBPHALLA JAMMU** is not charging any kind of fee from the students, including tuition fee, admission fee, or any other charges;

whereas, the school is being run on a charitable and non-profit basis for the welfare, education, and rehabilitation of orphan and underprivileged children, and all expenses are being met by the management through donations and voluntary contributions;

Now, therefore, in exercise of the powers conferred upon the undersigned under the relevant rules and regulations, it is hereby ordered that:

1. The fee for "**VED MANDIR PATHSHALLA, AMBPHALLA JAMMU**" as NIL (₹0).
2. The management shall **not collect/ charge any kind of fee** from the students.
3. This order shall remain in force unless modified or withdrawn by the competent authority.
4. The management shall comply with all other applicable rules, regulations, and conditions prescribed by the Education Department.

Accordingly, the fee fixation for "**VED MANDIR PATHSHALLA, AMBPHALLA JAMMU**" is hereby **approved as NIL (₹0)**.
