Subject: Approval of Review - Modification of Fee Structure of "LITTLE FLOWER HS HATLI MORH KATHUA."

Order NO. 918-Jm/FFRC of 2025

Dated 28 / 01 / 2025

The Management of Little Flower School has submitted an application for review against Order No. 320/FFRC/2025. It is stated that the School is running in deficit and is not in a position to bear daily expenses and requirements of the institution on the income based on the fee structure approved vide order dated 07.03.2025.

The School has requested:

- a) Approval of a one-time annual fee for new entrants @ Rs10,000/-.
- b) Enhancement of 10% in respect of existing Tuition Fee and Annual Fee.

The Committee has examined the application, supporting documents, and justification provided by the institution. The request has been reviewed in light of prevailing regulations, affordability for parents, and sustainability of the institution's operations.

It is noted that the School was running in a deficit of Rs11.00 lakhs as per the fee structure submitted at the time of filing with FFRC. The Committee had not considered the deficit amount during approval of the fee structure in the order dated 07.03.2025.

Upon consideration of the review application, the Committee hereby Approved the following revised fee structure:

1. One-time Annual Fee for new entrants of class nursery: Rs 5000/-
2. The revised fee structure shall be applicable from the academic session 2026-27.
3. The School shall ensure transparency in communication of the revised fee structure to parents and submit compliance to FFRC within 30 days.
