Subject: Review - Modification of Fee Structure of "LINTON HALL SCHOOL RAJBAGH SRINAGAR."

Order NO. 977-Jmu / FFRC of 2026

Dated 19 / 02 / 2026

A review application has been filed by the School Management against Order No. 58 FFRC of 2025, Dated: 14-01-2025. They have sought review of the order by seeking an enhancement of 40% in the tuition fee as well as the annual fee. It is also stated that a one-time annual fee has not been granted to the school management, which has been granted to other schools.

As per the fee structure submitted by the school at the time of submission file, the School was charging below mentioned Fee:

This Committee had regulated fee structure as per audit report submitted by the School management for the Sessions 2024-25, 2025-26 & 2026-27 vide order No. 58 FFRC of 2025, Dated: 14-01-2025, which is mentioned below:

The School Management approached the Hon'ble High Court vide WP(C) 1934/2025 with the plea that Fee approved by this Committee has slashed down by 8% and 28% in respect of Tuition Fee & Annual respectively. The Hon'ble Court directs that, the Committee order dated 14.01.2025 shall be kept in abeyance and Directed that, "the writ petition is disposed and this Court is Sanguine that the Competent authority shall examine the matter in the issue at the right earnest and after affording due/adequate opportunity to the petitioner before passing necessary orders in accordance with Law."

We have considered the application. Both the annual fee and the tuition fee have been fixed in accordance with the record submitted by the school. However, the school is running in deficit, therefore, in order to compensate the deficit amount, there shall be enhancement in respect of tuition fee over and above fee fixed vide order dated 14-01-2025) and annual fee on the basis of Rs 3000/-for the session 2024-25 and enhancement in annual fee for 2025-26 & 2026-27 on the basis of annual fee fixed for 2024-25 and in the case of the one-time annual fee, the same is hereby granted, as has been done in other cases. Accordingly, a one-time fee for new entrants of class Pre-nursery & nursery is allowed at Rs. 10000 for the session 2025-26 and Rs 11000/- for session 2026-27.

The School shall ensure transparency in communicating the revised fee structure to the parents.

"All other terms and conditions laid down in Order No. 58 FFRC of 2025 dated 14/01/2025 shall remain unchanged and in force."

MANAGEMENT DIRECTIVES & COMPLIANCE:

- 1) **QUALITY OF EDUCATION:** The Management shall accord priority to providing quality education and maintaining infrastructure as per the standards reported to this Committee.
- 2) **PROHIBITION TO AVOID COMMERCIALIZATION:** The School shall not sell uniforms or books within premises. Any tie-ups with specific vendors are prohibited; parents must have the liberty to purchase from the open market to exclude the possibility of vendor and school tie-ups which creates an impression of commercialization.
- 3) **FINANCIAL DISCIPLINE:** All fees collected must be deposited in a Scheduled Bank account. Transfer of funds to any Trust, AoP, or BoI is a violation of this order and shall lead to immediate action under law. The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.
- 4) **SALARY HIKE MANDATE:** The School Management shall ensure a reasonable annual increase in the salaries of its employees (teaching/non-teaching). Verification of this hike via bank statements must be submitted to the FFRC within 30 days of the start of the session.

- 5) **ADVERTISEMENT RESTRICTION:** No advertisement relating to the school shall be made in a manner that suggests a commercial enterprise. The school shall only publish FFRC approved fee structures and government notices.
- 6) **TRANSPARENCY:** The approved fee structure must be displayed on the School Notice Board and uploaded to the official website of the School.

" Non-compliance with the above directions shall attract penal action under the J&K Private Schools (Fixation of Fee) Rules".

The aforementioned Revised fee structure of the school has been approved by the Committee members of FFRC, J&K under the chairmanship of **"Hon'ble Justice Sunil Hali (Chairperson FFRC, J&K UT)"**.
