**Subject: REVIEW/ MODIFICATION OF FEE STRUCTURE OF " ST. JOSEPH'S HR. SEC. SCHOOL, BARAMULLA.**

**Order NO. 935-Jmu / FFRC of 2026**

**Dated 18 / 02 / 2026**

A review application has been filed by the School Management seeking review of Order No. 78 FFRC of 2025 dated 15/01/2025. It is stated by the school management that while regulating their fee structure, one-time annual fee has not been given to the school. It is stated that all other schools which were similarly placed with the school are getting the one-time annual fee. They also pray for giving 50% enhancement in fee structure as the school is running in deficit.

The Chairman FFRC, and the Officers of Administration of FFRC, inspected the school. The school has the requisite facilities, which are strictly in conformity with the guidelines. The school has good infrastructure and a very large campus. It is an old school of about 100 years. The school has constructed a new building with all the newly available facilities.

The prayer of the school seeking 50% enhancement cannot be permitted. However, from the records, it appears that the school is running in deficit, which fact was not taken into consideration and was overlooked at the time of fixation of the fee. Keeping in view the request made on their behalf, there shall be an enhancement of Tuition Fee @ Rs. 100 and an increase of 3% in Annual Fee from the current session over and above fee fixed vide order No. 78 FFRC OF 2025 dated 15.01.2025 and one time Annual Fee for new entrants of Class Nursery is approved @ 13000/- and Rs 14000/- for the session 2025-26 & 2026-27 respectively.
