**Subject: Review - Modification of Fee Structure of "G.D GOENKA PUBLIC SCHOOL GANGANSOO MORH JAMMU."**

Order NO. 1031-Jmu / FFRC of 2026

Dated 25 / 02 / 2026

A review application has been filed by the School Management against the Order No. 379 dated:13/04/2022. According to the School Management, the same fee was fixed for 2022-23 as it existed in 2019-2020.

The raise given by the Committee was 1.5% to 1.7% for consecutive three years. A review was filed by the School Management stating that the marginal increase made by the Committee was done arbitrarily, without examining the record and revenue and expenditure statements. It is further stated that when the application was submitted to the Committee for fixation of the fee for 2025-26 onwards, the Committee did not take into consideration the review application filed by the School Management against the marginal increase of the fee structure by this Committee vide Order No. 379 FFRC of 2022 dated 13/04/2022. As a result of this, the School has suffered loss.

We have considered the submission made by the School Management. On examining the raise given by the Committee vide order dated 13/04/2022, there is a marginal increase of 1.5% to 1.7%. Apparently, this increase is not supported by any documentary evidence. It is trite that fixation of fee is not an arbitrary exercise but has to be based on revenue and expenditure statements of the School Management.

It is also true that while fixing the fee and regulating the fee structure vide Order No. 562 dated 15/05/2025, the review application filed by the School Management was not taken into consideration and the fee structure was fixed on the basis of the fee fixed earlier vide Order No. 379. Therefore, it is necessary to accept the review application filed by the School Management against the order dated 13/04/2022, as a consequence of which a 5% rise for 2022-23, 2023-24, and 2024-25 is required to be made. Consequently, the fee structure vide Order No. 562 dated 15/05/2025 is also revised based upon the enhancement made in the fee structure for 2022-23, 2023-24, and 2024-25.

Accordingly, the Approval for the revised/modified fee structure is as under:
